of the Lake Ponchartrain Hurricane Protection Plan and the projected repairs to the Industrial Canal Lock in Orleans Parish, it has become plain to me that despite the overwhelming need for prompt resolutions to these complex problems, such resolutions may not be forthcoming for several years. The Corps has estimated that completion of the studies to resurrect the Hurricane Protection system around Lake Pontchartrain may take between two and four years. They have further estimated that completion of the project at the Industrial Canal Lock cannot be achieved before 1988.

Accordingly, I wish to go on record as having protested these inordinate delays, and to urge you and the Corps to do everything humanly possible to speed up the intervals required for study, design, and construction of these most important projects.

Thousands of human lives are dependent upon prompt completion of an efficient Hurricane Protection system. While the U.S. District Court has held that studies leading up to the acceptance of present plans were insufficient, I have no doubt that new studies, and, if necessary, new designs, can be undertaken, tested, agreed upon by all parties without undue delay, if only the Corps of Engineers is prepared to accept that task. For example, I am advised that an Environmental Impact Statement (E.I.S.) was recently completed for the Oil Storage Salt Dome Application by a private organization, Science Applications, Inc., in less than six months. If this be true, I find it hard to understand why an E.I.S. prepared by the Corps could take two to four years.
