As directed by ASA, our study effort for the Lake Pontchartrain, Louisiana, and Vicinity hurricane protection project is currently on hold awaiting further guidance from ASA. (As you will recall, Mr. Gianelli was given a detailed briefing on 10 November 1982 and was provided preliminary copies of the decision document in early December 1982. Further, ASA was furnished the printed final draft document along with OCE's views on the use of the Chief's discretionary authority on 31 March 1983. Additional information has been furnished informally.) We are approaching the critical stages of the schedule for this study effort. Any further delays will significantly impact the construction of the hurricane protection project. Efforts by your staff to get this off of dead center have been unsuccessful to date. I think it has reached the point where you should discuss this personally with Mr. Gianelli.

Summary of Major Actions

- 1. 1965 Project was authorized.
- 2. 1966 Barrier concept of protection was recommended.
- 3. Cost sharing Minimum 30% Non-Federal Cost
- 4. Construction initiated.
- 5. Currently 56%+ complete.
- 6. Jan 1975 EIS completed (on Barrier Plan).
- 7. Dec 1977 Barrier portion of project enjoined.
- 8. Dec 1978 Reevaluation initiated.

- 17. 18 Mar 83 Response from OCE indicating that OCE review of LMVD 16 Dec 82 data was nearing completion.
- 18. 31 Mar 83 Memo from Chief to ASA(CW) providing position on Chief's discretionary authority.
- 19. Several calls and discussion between LMVD, OCE, and ASA(CW).
- 20. 4 Aug 83 Letter from LMVD CDR to Chief urging Chief to discuss matter personally with Mr. Gianelli.

- 21.* 8 Aug 83 Informal notification that memo from ASA(CW) approving High Level Plan would be forthcoming.
- 22.* 16 Aug 83 Informal notification that memo had been received by COL Myers approving High Level Plan. Further that OCE was asked to provide drafts of letters for ASA(CW) use to inform concerned Congressional elements, i.e., Congressmen and committees.
- 23. 16 Aug 83 We await receipt of ASA memo and drafts (for our review) of OCE Congressional letters.
- * OCE was informed that no formal recommendation had been made and the final report was yet to be completed, and that coordination had not been accomplished. OCE indicated that Mr. Gianelli had been sold on the High Level Plan and therefore was approving it.
