**SUBJECT:** Withheld Funds in the FY 1992 Construction, General Work Allowance in the Lake Pontchartrain and Vicinity, LA Project

- 1. Reference CECW-BA memorandum, dated 1 October 1991, subject: Work Allowances for Fiscal Year 1992 Construction General.
- 2. Request that the HQUSACE withheld funds in the amount of \$4,300,000 in the Lake Pontchartrain and Vicinity, LA project (BECOO, CWIS 09350, Class 511) be transferred to the New Orleans to Venice, LA project (BEAOO, CWIS 12110, Class 511). Also, request that \$1,046,000 from the Mississippi River Ship Channel, Gulf to Baton Rouge, LA project (BBKOO, CWIS 55270, Class 211) be transferred to the New Orleans to Venice, LA project. The total transfer request to the New Orleans to Venice, LA project is \$5,346,000.
- 3. The \$4,300,000 HQUSACE withheld funds in the Lake Pontchartrain and Vicinity, LA project are no longer needed due to budget restraints in FY 93 for Orleans Outfall Canal floodwall, to lower estimated earnings for South Point to GIWW due to contractor default, and to downward adjustments in Planning, Engineering and Design, and Construction Management.
- 4. The \$1,046,000 from the Mississippi River Ship Channel, LA project is available due to delays in the approval process for the mitigation works in Phase I.
- 5. The \$5,346,000 is required in the New Orleans to Venice, LA project by the end of January 1992 to fund ongoing construction contracts and in-house work until June 1992.
- 6. A transfer data sheet is enclosed.
